## **Commercial Real Estate Scholarship Fund**

## **Scholarship Application**

The Central Florida chapter of NAIOP (the commercial real estate development association) in conjunction with its Diversity & Equitable Inclusion Committee is pursuing candidates for a **Diversity & Equitable Access Scholarship.** The format will be an *educational scholarship fund* to be awarded to students entering their sophomore to their senior year or pursuing a graduate degree. The student must demonstrate an intention to pursue a career in the commercial real estate industry or related fields through his/her/their course studies, employment or internships in the commercial real estate industry or other notable experience or achievements. Up to 10 scholarships will be granted in 2022 in the amount of \$1,000 or \$2,000 per semester. If the recipient resides in Central Florida area at the time of the award, the scholarship may also include a one-year student or graduate student (as applicable) membership to NAIOP Central Florida.

This scholarship is designated for students interested in career fields associated with Commercial Real Estate including careers such as, but not limited to:

- Real Estate Brokers
- Property Managers
- Commercial Lenders
- Land-Use Attorneys
- Real Estate Developers

- Urban Planners
- Civil & Environmental Engineers
- Architects
- Interior Designers

- Construction Managers
- Financial Investors
- Surveyors
- CAD Technicians
- Appraisers

#### APPLICATION CRITERIA:

- The applicant must be a full-time student (minimum 9 credit hours if pursuing a 2-year degree or 12 hours if pursuing a 4-year degree) and in good standing entering his/her sophomore year to senior year or a graduate program at one of the following colleges or universities: Seminole State College, Valencia Community College, Florida A&M University College of Law, Florida A&M University, Bethune Cookman, University of Florida, Florida State, or University of Central Florida.
- The applicant must be a citizen of the United States or Canada.
- The applicant must demonstrate an intention or interest in pursuing a career in commercial real estate, through course work, work experience and/or other notable achievements.
- The applicant must have a minimum 3.0 GPA on a 4.0 scale.



- The applicant must be willing to have his/her name, photograph and city of residence appear in promotional announcements by NAIOP Central Florida.
- The applicant must participate in a once per month meeting / phone call with their Commercial Real Estate Career Advisor through NAIOP Central Florida.
- Applications are accepted on a rolling basis and can be awarded mid-semester. However, applications will be evaluated in the order they are received.
- Scholarships will be paid out at the successful completion of the Semester assuming the above criteria have been met.

#### **INSTRUCTIONS TO APPLICANT:**

- Complete pages 3 through 6 of this application
- Submit with the application:
  - One letter of recommendation from a faculty member at the applicant's school. The applicant may submit one additional recommendation from another source, excluding a relative or family member (please submit an email and phone number for each recommender);
  - A copy of the applicant's transcript, through the date of the most recent grading period (which may be delivered directly from the applicable college or university at the request of the applicant);
  - o A copy of the applicant's resume;
  - o A list of professional extracurricular activities inclusive of volunteering and any other efforts for the advancement of equality and inclusion.; and
  - One Essay addressing the below topics (approx. 300-400 words total)
    - Explain your career goals and your interest in pursuing a career in commercial real estate (and in which particular field or profession in the industry);
    - Describe the greatest challenge or obstacle you have overcome. What did you learn about yourself?
